### I. Call to Order

## III. NMFTA Model Carrier-Broker Agreement

Prior to the meeting, a draft of the Model Carrier-Broker Agreement was sent to members of the Committee for their review in preparation for a vote to finalize the Agreement. Counsel Shapiro led the voting, in which Mr. Morgan made a motion to approve the Agreement. Mr. Hartman seconded the motion, and the Committee then unanimously approved it.

## IV. NMFTA Uniform Carrier Procedures (Best Practices) Publication: Detention

Prior to the meeting, a copy of the Detention Best Practices provisions was sent to Committee members for their review in anticipation of finalizing them at the meeting. One suggested modification was received, which Counsel Shapiro presented. There was no further discussion, so Counsel Shapiro led the vote to approve the provisions, as modified. A motion was made by Mr. Vander Pol, seconded by Mr. Cordero, and unanimously approved by the Committee to finalize the provisions for publication.

## V. Claims Procedures Rules in the NMFC

Ms. Franklin introduced this topic, which was submitted by a member of the Committee, to consider adding certain tariff verbiage to the Procedures Governing the Investigation and Disposition of Freight Claims for Loss or Damage items in the NMFC. Mr. Vander Pol extrapolated on the suggested additions, and a discussion was then held. Mr. Morgan made a motion to establish an ad hoc committee to review these suggestions, as well as other, currently published language in the Procedures Governing the Investigation and Disposition of Freight Claims for Loss or Damage provisions. The motion was seconded by Vice Chairman Vetterkind and approved by the Committee. An ad hoc committee will be established to conduct this review, and the findings will be presented at a future meeting.

## VI. Interline Procedures in the NMFC

Ms. Franklin presented the idea to the Committee to review the Interline Procedures in the NMFC, which may need some updating, due to their age. A brief discussion was held, after which Vice Chairman Vetterkind made a motion to create an ad hoc committee to further review the current provisions and determine which, if any, revisions are needed. Mr. Vander Pol seconded the motion, and it was approved unanimously by the Committee. An ad hoc committee will be established for this review, and the findings will be presented at a future meeting.

## VII. Cybersecurity – Carrier Transportation Contracts/Rules Tariffs

Counsel Shapiro relayed a suggestion sent by a couple of Committee members to develop language pertaining to cybersecurity protections in carrier transportation contracts or rules tariffs. A discussion was held, and it was determined that investigating and developing potential language for such contracts or agreements would be beneficial. Mr. Vander Pol made that motion, Mr. Whitney seconded, and it was then approved by the Committee. Potential language will be presented at the next meeting.

VIII. NMFTA Uniform Carrier Procedures (Best Practices) Publication: Other Topics Ms. Austin requested the Committee members to provide additional topics of interest for the NMFTA Uniform Carrier Procedures (Best Practices) Publication. A

discussion was held, and a motion was made by Mr. Whitney to conduct research to see if it is possible to define limited access locations. The motion was seconded by Vice Chairman Vetterkind and approved by the Committee.

- X. **New Business** Vice Chairman Vetterkind requested information relating to paperless delivery receipts for hazardous materials, including if they are permitted or if there is a standard. Mrs. O'Donnell will investigate the issue.
