Package 213

In solid fiberboard cartons complying with Item 222, except manufacturer's joint may be constructed by lapping sides of box one inch and firmly gluing 50 percent of area of contact the entire length of the joint. Not more than four cartons must be placed within a corrugated fiberboard four-sided sleeve testing 200 pounds. Cartons and sleeve must be shrink wrapped with polyethylene film of not less than 2.5 mils. Gross weight must not exceed 20 pounds.

Where the provisions of other tariffs apply, and those provisions specify a limitation of the carrier's liability absent a release or value declaration by the shipper, the carrier's liability shall be limited to the extent provided by such applicable provisions when the shipper does not make the requisite or specified release or value declaration.

Analysis

Introduction

A proposal on “Glassware” was initially discussed by the FCDC at its public meeting on March 10, 2026, in Savannah, GA. During that meeting, comments were made suggesting the FCDC’s 13-subprovision density scale would be appropriate for the involved items. The items in the initial proposal were reviewed with the intent of removing value-based provisions, combining like commodities, and examining the involved products’ transportation characteristics. The FCDC subsequently voted to withdraw that proposal pending further research. The FCDC expanded the scope of this proposal to include all items in the Glassware Group, as shown in the Present Classification Provisions herein.

SUBJECT XX

Transportation Characteristics

Handling, Stowability, and Liability—While glassware can be of a fragile nature, there appears to be no significant handling, stowability or liability issues when tendered with proper interior and exterior packaging.

Conclusion

Based on the foregoing analysis, this proposal identifies density as the primary transportation characteristic and would cancel twenty-four items with reference to item 88160 which would be amended to name "Glassware," with a "viz." format, and would maintain classes predicated on the FCDC's full-scale, density-based provisions¹.

Fourteen Notes and the Glassware Group, item 87500, would be canceled with no further application. The indentations for item 88160 would be adjusted accordingly.

Additionally, items 87570 and 87760 would be canceled with reference to the full-scale, density-based provisions of item 56290², and item 88080 would be canceled with reference to the full-scale, density-based provisions of item 57810³.

Item 87650 would be canceled as obsolete.

The FCDC's Lead Classification and Packaging Analyst has reviewed the proposed minimum packaging requirements and determined they are appropriate for the LTL environment. Accordingly, Note, item 87813 would be canceled and reestablished attendant to item 88160, and a new Note would be established to provide additional packaging requirements. Package 213 would also be canceled with no further application.

Item (Rule) 172 would be amended to remove reference to item 88160.
