SUBJECT XX**Analysis and Conclusion**

This proposal is in response to interpretive concerns regarding balloons. In the interest of clarification and simplification, and to alleviate these interpretive issues, item 21300 would be canceled with reference to item 21320. Furthermore, a new item would be established applying on "Balloons, toy or novelty" which would provide classes based on the FCDC's 13-subprovision density scale.

Additionally, Note, item 21321 would be amended accordingly to clarify the application of item 21320.

The FCDC's Lead Classification and Packaging Analyst has reviewed the proposed minimum packaging requirements and determined they are appropriate for the LTL environment.
