Analysis

Introduction

Five items, as shown in the Present Classification Provisions herein, name particular types of trays, and these provisions can be difficult to interpret, apply, or verify.

Transportation Characteristics

Handling, Stowability, and Liability—There have been no reports of unusual or significant handling, stowability, or liability issues. Therefore, density has been identified as the primary transportation characteristic.

SUBJECT XX**Conclusion**

Based on the foregoing analysis, item 187360 would be canceled with reference to the full-scale, density-based provisions of item 40775¹, item 187240 would be canceled with reference to the full-scale, density-based provisions of 57410¹, and item 187440 would be canceled with reference to the full-scale, density-based provisions of item 199970¹. Concurrently, the descriptions of items 40775, 57410, and 199970 would be amended.

Items 187230 and 187340 would be canceled with reference to provisions otherwise applicable. Note, item 187232 would be canceled with no further application, as would the Trays generic heading, item 187200.

The FCDC's Lead Classification and Packaging Analyst has reviewed the proposed minimum packaging requirements and determined they are appropriate for the LTL environment.
