SUBJECT XX**Analysis****Introduction**

Seven items in the Zinc or Zinc Alloys Group, as shown in the Present Classification Provisions herein, name particular types of products composed of zinc or zinc alloys, and these provisions can be difficult to interpret, apply, or verify.

Transportation Characteristics

Handling, Stowability, and Liability—There have been no reports of unusual or significant handling, stowability, or liability issues. Therefore, density has been identified as the primary transportation characteristic.

Conclusion

Based on the foregoing analysis, items 200740, 200840, 200860, 200870, 200880 and 200890 would be canceled with reference to the full-scale, density-based provisions of item 135955¹. Item 201050 would be canceled with reference to the full-scale, density-based provisions of items 56290¹, 61700¹, 95190¹, 135955¹ and provisions otherwise applicable, and Note, item 201051 would be canceled with no further application.

Additionally, the Zinc or Zinc Alloys Group, item 200480, would be canceled with no further application.

The FCDC's Lead Classification and Packaging Analyst has reviewed the proposed minimum packaging requirements and determined they are appropriate for the LTL environment.
