Analysis

Introduction

Five items naming various types of stands and tables, as shown in the Present Classification Provisions herein, can be difficult to interpret, apply, or verify.

Transportation Characteristics

Handling, Stowability, and Liability—There have been no reports of unusual or significant handling, stowability, or liability issues. Therefore, density has been identified as the primary transportation characteristic.

Conclusion

Based on the foregoing analysis, items 178695, 178710, 178715, 178716, and 178717 would be canceled with reference to the full-scale, density-based provisions of items 79300 and 178690¹⁵. Item 178695 would be canceled with reference only to item 178690.

Furthermore, Note, item 178696 would be canceled with no further application.

The FCDC's Lead Classification and Packaging Analyst has reviewed the proposed minimum packaging requirements and determined they are appropriate for the LTL environment.

¹⁵ Items 79300 and 178690 provide the FCDC's standard 13-subprovision density scale, which includes reference to Item (Rule) 170, the inadvertence clause.
